- 2. Busiest days were September 8 and September 22. Thursday was our most popular day this month. Substantially all those visitors come through the front page to the autocross page. This month saw the Classifieds page continue to be the third most popular page followed closely by Rennsport IV.
- 3. The most downloaded flyer this month were the Porsches on the Plaza and the two autocross results.
- 4.Daily country activity was United States, China, Russian Federation and Sweden accounting for 91% of the visitors.
- 5. Substantially all the visitors to the website this month came to it directly. Search engines, Google and Yahoo referred 231 visitors. PCA National referred 52 visitors this month. Dogpile referred one (search phrase santa rosa porsche club). The most popular search phrase this month was "pcaredwood" as opposed to "redwoodpca" last month.

- 6. An unusual search phrase that led to our site was "we're sorry. we closed your session for your security/privacy. tirerack firefox.".
- 7. Other operating systems used to access the website, i.e. ipads, pods, and androids accounted for 129 visitors this month.
- 8. Our most popular spiders were Yahoo! Slurp, Bing Robot, Googlebot and Baidu Spider. The Sosospider came by 63 times but only visited the front page. I guess that's why it's a so-so spider.
